**EDUCATIONAL NOTICE
(For admission into BAMS/BHMS Course)**

Declarations are invited from the eligible candidates of NEET-UG-2025 for State quota seats for admission into BAMS/BHMS course in **Govt. Ayurvedic College, Jalukbari, Guwahati-14 and SJN Homoeopathic Medical College & Hospital, Guwahati-37** in the State of Assam for the session 2025-26.

To be eligible for State Quota seat

- a) The candidate must be a citizen of India.
- b) The candidate must be a permanent resident of Assam. The Father/Mother or the candidate must be residing in the State of Assam continuously for not less than a period of 20 years. Provided that this shall not be applicable to the sons/daughters of officers of All India Services allotted to Assam.
- c) The candidate must study in all classes from class-VII to XII in the State of Assam and must pass the Qualifying Examination or its equivalent examination from any institute situated in the State of Assam.

Provided that, if a candidate studies outside Assam from class-VII onwards because his/her father/mother is posted outside Assam as an Assam State.

Government employee or as Central Government Employee or as an employee of a Corporation/Agency/Instrumentality under Govt. of Assam or Central Govt. whether on deputation or transfer or regular posting, then the period for which the said father/mother is working outside the State be relaxable for such candidate.

The "Declaration Forms" are available in the website of Directorate of AYUSH, Assam i.e. <https://ayush.assam.gov.in> and website of the Govt. Ayurvedic College, Guwahati-14 i.e. <https://gachguwahati.in>. The duly filled up Declaration Form must be submitted to the Office of the Principal, Govt. Ayurvedic College, Jalukbari, Guwahati-14, on or before 26th September 2025 up to 5:00 P.M.

The incomplete Declaration Form shall be summarily rejected.

N.B:Candidates are advised to visit the official website of the Directorate of AYUSH, Assam (<https://ayush.assam.gov.in>) from time to time for updates and notifications regarding the schedule of counselling. The list of the candidates who have submitted their declaration form and list of the summarily rejected candidates will be published in the same website mentioned above.
