**COUNSELING FOR SELECTION OF CANDIDATES FOR PROVISIONAL ADMISSION
 IN TO BAMS/BHMS COURSE IN GOVT. AYURVEDIC COLLEGE, GUWAHATI AND SJN
 HOMOEOPATHIC MEDICAL COLLEGE & HOSPITAL, FOR THE SESSION 2025-26.**

It is for general information of all eligible candidates of NEET-UG-2025 who submitted the **Declaration Form** for admission into BAMS/BHMS course at **Govt. Ayurvedic College, Guwahati-14** and **SJN Homoeopathic Medical College & Hospital, Guwahati-37** for the session 2025-26, that the counseling for selection of candidates for admission into BAMS/BHMS course will be held on **22/10/2025 at 09.30 A.M. in Govt. Ayurvedic College, Jalukbari, Guwahati-14**. The candidates are to appear before the Selection Board for selection for provisional admission, subject to fulfillment of the eligibility criteria of the Government Ayurvedic College, Guwahati and Homoeopathic Medical Colleges of Assam (Regulation of Admission into BAMS/BHMS courses) Rules, 2020.

The eligible candidates must bring with them duly filled up **APPLICATION FORM of Schedule-1** along with all relevant Annexure Certificates in original attached with the Application Form, Marks sheets of 10+2 (Sc.) examination, Admit Card of HSLC or equivalent examination, Pass Certificates of HSLC or equivalent examination, Pass Certificates of 10+2 (Sc) or equivalent examination, PRC, Caste & other reserved category certificates, NCL if applicable, Admit Card and Score Card of NEET(UG)-2025 and other relevant documents in original. A set of photo copies of all the said documents duly signed by the candidate himself/herself are to be submitted along with the Application Form at the time of counseling.

All candidates must appear personally for counseling on the scheduled dates and time failing which he/she will forfeit his/her merit position and no claim shall be considered later.

The candidate shall be required to deposit an amount of **Rs. 500.00 (Rupees five hundred)** only as counseling fee through Treasury Challan into State Exchequer under Head of Account "**0210-03-102-0000-000-00-00-EE-V-GA**". The copy of the deposit Challan (Original/Duplicate/Triplicate) must be submitted at time of Counseling.

The Selection will be made in accordance of merit position of the NEET UG-2025 as per the Admission Rules.

In case of any matter of controversy, the decision of the **Selection Board** shall be final and binding.

All the NEET-UG-2025 qualified candidates, who submitted the Declaration Form and eligible for admission in to BAMS/BHMS course as per the Government Ayurvedic College, Guwahati and Homoeopathic Medical Colleges of Assam (Regulation of Admission into BAMS/BHMS courses) Rules, 2020.

Important Note:-1. For OBC/MOBC (NCL) Category candidate:-

- I. They must submit the original Non-creamy layer (NCL) OBC/MOBC certificate issued by the D.C. of the concerned district.
- II. The annexure-III of the Application Form to be submitted by OBC/MOBC category candidate must clearly show the candidate belongs to Non-creamy layer.

In case of any controversy, the decision of the Selection Board shall be final and binding.

2. For Economically weaker section (EWS) Quota:-

The EWS certificate issued by the concerned authority must be submitted at the time of counseling for the said category candidates.

The **APPLICATION FORM** shall be available in the official website of Directorate of AYUSH, Assam i.e. <https://ayush.assam.gov.in>). Further, the relevant notification (if any) and list of the selected candidates for admission into BHMS course will be published in the website <https://ayush.assam.gov.in> in due course of time. All the candidates are advised to visit the website accordingly.
