It is for general information to all category of candidates who qualified in NEET UG -2025 and submitted the **Declaration Form** for admission into BAMS/BHMS course in Govt. Ayurvedic College, Guwahati/SJN Homoeopathic Medical College & Hospital, Guwahati for the session 2025-26 that the 2<sup>nd</sup> counselling has been scheduled to be held on 20<sup>th</sup> of November 2025 at 09:30 AM, at **Govt. Ayurvedic College, Guwahati-14** for selection of the candidates for admission into BAMS/BHMS course in Govt. Ayurvedic College, Guwahati and SJN Homoeopathic Medical College & Hospital, Guwahati for the session 2025-26, against the vacant seats/subsequent resultant vacancies or any vacancies arises during the course of time under any category.

The eligible candidates must bring with them duly filled up **APPLICATION FORM of Schedule-1** along with all relevant Annexure Certificates in original attached with the Application Form, Marks sheets of 10+2 (Sc.) examination, Admit Card of HSLC or equivalent examination, Pass Certificates of HSLC or equivalent examination, Pass Certificates of 10+2 (Sc) or equivalent examination, PRC, Caste & other reserved category certificates, NCL if applicable, Admit Card and Score Card of NEET(UG)-2025 and other relevant documents in original. A set of photo copies of all the said documents duly signed by the candidate himself/herself are to be submitted along with the Application Form at the time of counseling.

Candidates are to appear personally before the Selection Board along with all documents on the scheduled date and time as mentioned above, failing which he/she will forfeit the merit position and no claim shall be considered later.

The candidate shall be required to deposit an amount of Rs. 500.00 (Rupees five hundred) only as counseling fee through Treasury Challan into State Exchequer under Head of Account "0210- 03- 101-0000-000-00-00-EE-V-GA".The copy of the deposit Challan (Original /Duplicate/ Triplicate) must be submitted at time of Counseling.

The admitted candidates/selected candidates or candidates of waiting list for admission into BAMS/BHMS course for the session 2025-26 as per the counseling held on 22<sup>nd</sup> October, 2025 will also have to appear the counseling for admission against said vacant seats if desire for admission.

The admitted candidates/selected candidates or candidates of waiting list as per counseling held on 22<sup>nd</sup> October, 2025, are not required to submit Application Form of Schedule-1 and also not required to deposit the counseling fee for the 2<sup>nd</sup> counseling.

**There will be spot admission and all the selected candidates must complete their admission on the day of counseling.**

Further, any vacancy arises during the course of time before cutoff date of admission, will be filled up from the admitted/selected candidates or waiting list as the case may be, category wise on the basis of merit as prepared by the Selection Board during 2<sup>nd</sup> counseling.

The Selection will be made in accordance of merit position of the NEET UG-2025 as per the Admission Rules.

**ImportantNote:-**

1. For OBC/MOBC (NCL) Category candidate:-

- I. They must submit the original Non-creamy layer (NCL) OBC/MOBC certificate issued by the D.C. of the concerned district.
- II. The annexure-III of the Application Form to be submitted by OBC/MOBC category candidate must clearly show the candidate belongs to Non-creamy layer.

2. For Economically weaker section (EWS) Quota:-

The EWS certificate issued by the concerned authority must be submitted at the time of counseling for the said category candidates.

**In case of any matter of controversy, the decision of the Selection Board shall be final and binding.**
