EDUCATIONAL NOTICE

Applications are invited as per the Assam Ayurvedic College (Regulation of Admission to Post-Graduate Course) Rules, 2021, from the eligible candidates who qualified in AIAPGET-2025 examination and aspiring for admission into MD/MS (Ayur) courses in Govt. Ayurvedic College, Guwahati for the session 2025-26, against the State (Assam) and NEC quota seats.

For State Quota Seats, the candidate must- (a) be a citizen of India; (b) be a permanent resident of Assam and must furnish a certificate to this effect.

For NEC Quota Seats, the Secretary, North Eastern Council (N.E.C.) shall recommend the candidates through a certificate at Annexure-I in the Application Form at Schedule-III.

For Medical Officer (Ayurvedic) Quota Seats, the candidate (a) must complete minimum five years of regular service on or before 31st July/2025 as Medical Officer (Ayurvedic) under State Health Services, Assam, (b) applying for the Medical Officer Quota seats shall have to submit the duly filled up Application Form as appended in Schedule-III with recommendation of the appointing authority at Annexure-II of the Application Form.

The candidate shall be required to deposit an amount of Rs. 500.00 (Rupees five hundred) only as counseling fee through Treasury Challan into State Exchequer under Head of Account "0210-03-101-0000-000-00-00-EE-V-GA". The copy of the deposit Challan (Original/Duplicate/Triplicate) must be submitted at time of Counseling.

The Applications Form is available in the website of the Directorate of AYUSH, Assam (i.e. <https://ayush.assam.gov.in>.) and website of the Govt. Ayurvedic College, Guwahati-14 (i.e. <https://gachguwahti.in>).

The duly filled up Application Form along with its enclosures must be submitted to the Office of the Principal, Govt. Ayurvedic College, Jalukbari, Guwahati-14, during office hour, on or before 17/11/2025.

The eligible/shortlisted Candidates and date of counseling for selection of candidates for admission into the course, will be published in the website <https://ayush.assam.gov.in> and <https://gachguwahti.in> in due course of time. All the applicants are advised to visit the website accordingly.
